Call to Order

Attendance

Approval of previous minutes: November 13, 2018.

Goals of the committee: Review of accomplishments & future priorities

- More precisely defining the boundaries of the “no-build” areas to be preserved; more securely protecting those areas as permanent open space. *Elsa and Larry to do.*
- Find funding or partners to implement the planting plans for the Fountain Garden and Great Lawn areas, especially increasing native plants, pollinators, wildlife habitat. *Supporters of Oak Hills Park 501(c) funded nearly \$500 worth of bulbs, ordered 9/29. We thank Ernie DesRochers for his substantial contribution!*
In addition to 501(c)3, Lisa has made contact with Pollinator Pathway and Norwalk River Watershed Assn. Lisa and Elsa met with OHP horticulturist Anthony Hylton to discuss planting plans for Fountain Garden and Great Lawn.
- Maintain the trails and continue improving them (accessibility, control of invasives). *Elsa has discussed with Anthony Carrano (Eagle Scout project 2018-19). Photos of trail stairs on steep areas.*
- Kiosk, trail map, interpretive signs, plaques to identify trees, wildlife. *See The Hour article about Eagle Scout project in Wilton: building benches from fallen trees.*
- Educational opportunities, especially for young people. *Nature photos/artwork in restaurant entry space OK by restaurant mgr. Joe Montalto and OHPA Chair Bill Waters. Audrey working with photos and a sketch or mockup. We met Thursday 11/15 at 12 noon.*
- Marketing, Budget, Time Frame: *separate email list for nature & restaurant*
- Encouraging sustainable land use practices in Oak Hills Park. *Horticulturist Anthony Hylton is aware of this goal.*

Reports

- Supporters of Oak Hills Park 501(c)3 is alive and well. *Thanks to Audrey, Lisa, Marie, and Larry & Sharyn for their contributions. We have an interest-bearing checking account at Norwalk Bank & Trust (Connecticut Community Bank) <https://www.ccbankonline.com/>. Suggestions to revisit possibilities for grant funding.*
- Events: *Winter Trail Walk with Rich Whitehead tentatively set for Saturday, February 23 (the Saturday after Presidents' Day) with Saturday, March 2 as the snow date. For more ideas, see other organizations, e.g. Norwalk Land Trust, CT Forest & Park Assn., Norwalk River Valley Watershed Assn.*
- Fountain Garden and Great Lawn status: *See above, list from Anthony Hylton and funds from 501(c)3 for bulbs. Jim Schell is aware of need for a trash receptacle.*
- Design and placement of identification plaques, ground-mounted interpretive signs.
- Oak Hills Park Authority members said they personally would donate toward cost of a

kiosk. Here is the one at Farm Creek as an example:

- McNeil Design Collaborative annotated map and survey need review (help from Alexis Cherichetti?) to provide exact coordinates of boundaries between nature areas & golf areas.
- Educational outreach, emphasis on appreciating and protecting nature.
