

# City of NORWALK, CONNECTICUT *proposed* ZONING REGULATIONS UPDATE

## SCHEDULE & OUTREACH

The City has historically recognized nine (9) main neighborhood groups. For those areas without active neighborhood groups, Staff will work closely with the Council members within those districts regarding additional outreach. For smaller neighborhood groups Staff will accommodate meeting requests during normal business hours.

## **PLANNING & ZONING COMMISSION**

### **Commission Meetings & Process**

- While the other outreach meetings are occurring, the Planning & Zoning Commission and Staff will be reviewing various specific aspects of the Draft Regulations, such as single-family zoning, multi-family zoning, grading, flood hazard zone, sustainability, et cetera.
- The Planning & Zoning Commission will conduct two (2) formal public hearings/listening sessions on the draft regulations, on **June 21<sup>st</sup>** and **June 28<sup>th</sup>**.
- Following the public hearings, the Commission will review information collected both written and in-person and collate the comments for consideration of additional edits to the regulations, prior to taking any action on the draft regulations.
- At this time, we anticipate an additional hearing and possible adoption of the revised regulations in late September, with an effective date planned for January 1, 2024.

### **Other Governing or Regulatory Bodies**

- If requested, staff will present the regulations and answer questions from City agencies including Common Council and any land use boards or advisory bodies.
